RESOLUTION 2019-69

**A RESOLUTION TO PROCEED WITH PRESENTING THE ADDITION OF AN
OPERATING LEVY IN EXCESS OF THE TEN-MILL LIMITATION, TO THE
ELECTORATE AND DECLARING EMERGENCY**

WHEREAS, this Council seeks to proceed with presenting an additional operating levy in excess of the ten-mill limitation to the electorate;

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF HARVEYSBURG, WARREN COUNTY, A TWO THIRDS MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. That the requested additional operating levy in excess of the ten-mill limitation for the benefit of this Municipality be enacted, for the purpose of *street maintenance* at a rate not exceeding two and one half (2.5) mills for each one dollar (\$1.00) of valuation, which amounts to twenty-five cents (\$.25) for each one hundred dollars (\$100.00) of valuation, for a period of five (5) years, commencing in 2020, first due in calendar year 2021, has been certified by the County Auditor.

Section 2. That the Village Council now seeks to proceed with the presentation of the levy to the electorate. That the question of passage of an additional operating levy shall be submitted to the electors of this Village at an election to be held in March 17, 2020. If approved by the electors, said tax levy shall be placed upon the 2020 tax list and duplicates, for the first collection in calendar year 2021.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees that requested such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 122.22 of the Ohio Revised Code, and the rules of this Council adopted in accordance therewith.

Section 4. That this resolution is hereby declared to be an emergency measure for the purpose of meeting the filing deadline for voter consideration and thereby preserving the health, welfare, and morals of the community.

Section 5. This Resolution shall be deemed an emergency measure for the Village welfare and thereby the three readings as required by law are waived.
