RESOLUTION 2023-04

A Resolution to extend the Village of Harveysburg solid waste and recycling services agreement with Rumpke and to increase the monthly solid waste and recycling rate;

WHEREAS, the Village of Harveysburg needs to modify the cost of trash and recycling being charge to its residents and/or businesses in the Village of Harveysburg because the contractor had a rate increase to keep pace with inflation.

Now, therefore, be resolved by the Council of the Village of Harveysburg, Warren County, Ohio two thirds of all members elected concurring that:

NOW THEREFORE BE IT RESOLVED, that the following charges will be applied effective May 1, 2023.

Section 1:

That the new solid waste rate shall be \$17.85 per month.

That the new recycling rate shall be \$5.88 per month.

That the extension will cover the period of May 1, 2023, through May 1, 2025.


Section 2:
